Terms of use for the amusement Freizeitpark Fürstenau (as of 2017)

§ 1 Scope

These conditions of use apply to the stay at the Freizeitpark Fürstenau and in particular all legal relationships between the Freizeit- und Ferienpark Fürstenau GmbH (hereafter: amusement park) and their customers as well as other users of the amusement park. The amusement park does not accept contradictory or deviating conditions from these Terms of Use, unless the amusement park has expressly agreed to their validity in writing.

§ 2 Important safety rules and hazard warnings

1. General

The site of the amusement park poses a risk of injury to the user and also the risk of damage to the vehicle to the motorized user, for example due to a sand pit resulting pit, about 30 m deep and other, resulting from the earlier use as a tank test track terrain structures.

- a) The use of drugs in the amusement park and the entrainment of animals with the exception of dogs in the amusement park is prohibited. Dogs are to be kept on a leash.
- b) In the area of the winch, no persons may be present during their use. Risk of death!
- c) Archery may only be carried out under the supervision of the staff. The bow must always be aligned so that nobody can be endangered or injured by an arrow. It may only be fired if there are no persons in the danger zone in front of or behind the target. Risk of death!
- d) On the paintball field is the prescribed protective clothing, especially the mask, always wear.
- e) Instructions and signs of the staff and the information on panels are to be observed with all activities exactly.
- f) The search for foreign objects and the entrainment of objects from the amusement park are prohibited.
- g) Trees or shrubs or branches must not be felled, cut off, used as firewood or otherwise damaged.

2. Use of vehicles

- a) The permitted maximum speed is, unless otherwise expressly permitted, 30 km / h on the entire site.
- b) Persons under the influence of alcohol may not drive vehicles in the amusement park.
- c) Equipment and obstacles for all-terrain vehicles (eg bridge, seesaw, winch, cross-axel, washboard, sand pit, hole) may only be used on suitable all-terrain vehicles.
- d) The use of vehicles in the amusement park is permitted only on the marked roads, paths and off-road tracks. It is forbidden to drive in the forest before sunrise and after sunset.
- e) The use of vehicles in the amusement park is only allowed if:
 - the vehicle is approved for traffic on public roads, is insured and safe for traffic and has, as required by law, a valid inspection sticker (TÜV sticker),
 - the vehicle complies with the regulations of the StVZO and the StVO and
 - the driver has reached the age of 18 and is in possession of the legally required driving license.
- f) Prescribed seat belts must be worn while driving. When using karts, quads and buggies, wear a suitable safety helmet and appropriate protective clothing.
- g) The equipment of the vehicles, especially the tires, is to be adapted to the sometimes very heavy terrain in the amusement park and to the respective weather conditions.

§ 3 Limitation of liability

1. Claims of the customer or user for damages in connection with the use of the amusement park are excluded. This does not apply to damages resulting from injury to life, limb or health, which are based on a culpable breach of duty by the amusement park or its auxiliary persons and other damages based on an intentional or grossly negligent breach of duty by the amusement park or its auxiliary persons.
2. Is a damage that is not damage from injury to life, limb or health, on the simple negligent breach of a fundamental contractual obligation or on the simple negligent violation of an obligation whose fulfillment makes the proper execution of the contract in the first place and on their Compliance with the customer or user may rely regularly, the amusement park is also liable for such damage. However, liability in these cases is limited to foreseeable and typically occurring damage.

§ 4 Booking, non-attendance at booked events

1. The booking of place and date of each experience is possible by e-mail, by phone or in person in Fursten Forest. A booking is possible up to a maximum of 12 months in advance. After booking, the participant will receive a booking confirmation in which the name, address, telephone number and e-mail address of the organizer will be announced. The contract between the participant and the organizer comes about with the sending of the booking confirmation. The terms and conditions of the organizer become an integral part of this contract.
2. A free cancellation is possible up to 7 days before the event day, from 20 persons up to 4 weeks before the event.
3. If canceled later than 7 days / 4 weeks before the event or if you do not participate in the event without prior cancellation, the cancellation fee will be 100%. If you are in possession of a voucher, it is deemed to have been redeemed. A refund of the possibly paid online payment is therefore also not possible.

§ 5 Cancellation policy for Fursten Forest

If a reservation is made for a group with or without breakfast, for a group, the following cancellation policy applies to the cancellation of this reservation:

- a) More than 3 months before the booked time, free cancellation possible.
- b) Between 2 months and 3 months before the booked arrival date, 15% of the cost will be charged.
- c) Between 1 month and 2 months before the booked arrival date, 35% of the cost will be charged.
- d) Between 14 days and 1 month before the booked arrival date, 60% of the cost will be charged.
- e) Between 7 days and 14 days before the booked arrival date, 85% of the cost will be charged.
- f) For 7 days or less before the booked arrival date, 100% of the cost will be charged.

§ 6 No insurance in favor of customers and users

The amusement park does not maintain any insurance that would cover the risk of customers and users associated with the use of the Amusement Park (eg personal injury, damage to the vehicle). The liability of the amusement park in the extent limited according to § 3, for which the amusement park maintains a liability insurance, remains unaffected.

§ 7 Environmental Codex

In addition to our house rules, we have an environmental code derived from the guidelines of the Dutch Association of Off-Road Vehicle Clubs (FNTC). We have set up this environmental code out of respect for nature. We want to protect and maintain the flora and fauna in this area so that many more generations can enjoy it.

Environmental Codex on closed terrain:

- Always follow the instructions of the organization.
- Drive calm and controlled.
- Follow the designated route.
- If you have to drive a detour, avoid the green areas.
- Do not cause unnecessary noise.
- Do not leave any trash behind.
- Do not bother the other visitors.
- Make sure the SUV is free of oil and grease.
- Perform repairs in the field on a liquid-tight surface.
- When leaving the premises make sure that the vehicle lighting and license plate comply with the applicable traffic regulations.
- Make sure that your tires are not a nuisance to other road users.

Environmental Codex on dirt roads:

- Only drive where permitted and only on the specified routes. It is important that you clarify in advance (using the map with additional information) on which routes can and may be driven. Do not deviate from the given routes. In no case create your own routes! Other drivers will be able to follow the trails you left behind, causing unnecessary damage to nature.
- Show respect for nature and the environment. Be extra careful and pay special attention to game with boys. Avoid damage to trees and plants. Watch out for the risk of fire. Do not pollute nature with garbage or waste. Make sure that the vehicle is free of oil and grease residues. Perform repairs in the field on a liquid-tight surface.
- Respect the rights of third parties. Do not open grates or the like that are obviously designed to deny passers-by.
- Observe the traffic rules, traffic signs, traffic signs and respect the other road users. Non-compliance with the basic traffic rules often causes annoyance to other road users.
- Make sure that you do not hinder cyclists, pedestrians and riders who are on the racetrack. Drive around generously if necessary or decrease your pace. Adjust your pace and avoid unnecessary dust clouds. Also try not to spill anyone with water or mud. Do not cause any annoyance (including noise pollution) to others. A friendly greeting when driving over creates a good atmosphere.

Anyone who does not knowingly obey house rules and the Code will be removed from the site and excluded from further visits.

§ 8 House Rules campsite

In order to allow all guests a pleasant stay on our campsite, we have set up the following house rules. Please read carefully and abide by the rules so that all guests feel comfortable with us.

Camping rules

01. The camping site is open every day from 9:00.
02. Arrival to the square is possible until 22:00 on Fridays and Saturdays.
03. After 22:00, the reception is closed and motorized vehicles will not be able to drive to the grounds. Access is possible on foot.
04. Sunday to Thursday inclusive, access to the square is possible until 17:00. After 17:00 the reception is closed and motorized vehicles will not be able to access the grounds afterwards. Access is possible on foot.
05. If serious difficulties occur on the pitch, please call the security service Heyer:
Tel: 0162 2498785. If you need medical attention or the fire department, dial 112.
06. Trailers are parked outside the campsite.
07. If you expect guests during the day, please inform the reception.
08. Off the designated fire pits, open fire is strictly prohibited.
09. Barbecues are allowed. Have a bucket of water ready in case of emergency.
10. At no point is it allowed to cut down trees or saw off or bend branches to make a fire.
11. It is not allowed to search the area with metal detectors or probes.
12. Please play music only quietly and with sufficient distance to the neighbor.
13. At 23:00, the night's sleep begins.

Dogs

01. Dogs are to be leashed all over the premises.
02. Dung from your dog must be disposed of immediately (dog shoveling duty).
03. Gassi please go outside the campsite. Nearby you will find suitable broad embankments.

Toilets and hygiene

01. Smoking in the toilets is not allowed.
02. Please dispose of the contents of chemical toilets or such containers only in our disposal center and not in the toilets of the toilet building. The disposal center can be found in front of the sports grounds.
03. Keep the building clean. Give garbage and waste no chance.
04. Please help us with the waste separation.
05. You will find our refuse collection point in front of the campsite.

Disclaimer

The campsite owner is not liable for the consequences of injury or material damage occurring during the stay at the campsite. If one of the above rules is disregarded, the campsite owner / operator has the right of the person concerned to refuse further access to the site. In cases not covered by this House Rules, the campsite owner / operator decides.
